Consolidated Pay: As to be framed by the Department of Higher Education, Govt of West Bengal

Age: Retired persons in between 60 to 65 years of age.

Qualifications:

- i. Uniformly good academic record with a Master’s Degree in Commerce/Finance with minimum 55% of marks or Chartered Accountant/Cost Accountant or MBA with specialisation in Finance.
- ii. At least 15 years of experience in management of finance in a Government/University or Institute of Higher Learning/ Commercial Establishment of which 5 years must be in higher administrative post involving supervision, control, planning and administration.

OR

High level of administrative experience in government/quasi-government/government undertaking or a good background in administration and management in a senior position.
